Re: **Fujifilm's Notice of Default and Final Demand for Payment Prior to Litigation**

Messrs. Barber and Paley:

As you know, FUJIFILM North America Corporation ("Fujifilm") and Marketing.com, LLC ("Marketing.com"), entered into an Installment Payment Agreement for Past Due Amounts, dated January 2, 2026 (the "Agreement"). After receiving no response to prior notices and demands, on March 9, 2026, Fujifilm issued a Notice to Marketing.com Regarding Fujifilm's Exercise of Its Option to Require Immediate Payment of Entire Unpaid Balance, wherein Fujifilm demanded the immediate payment of the entire Unpaid Balance of \$347,054.31. Marketing.com failed to make payment as required. This constitutes a further Default of the Agreement.

Fujifilm demands that Marketing.com cure this Default and pay Fujifilm **\$347,054.31** by **March 23, 2026**. Otherwise, Fujifilm will commence litigation.

Please note that if Fujifilm does not receive payment by that date, Marketing.com will also owe 10% late fees on the entire Unpaid Balance in the amount of \$34,705.43, pursuant to Section 5.e of the Agreement. In addition, if Fujifilm is forced to file a lawsuit to enforce the Agreement, under Section 5.f., Fujifilm will be entitled to recover its attorneys' fees and costs.

Fujifilm reserves all of its rights and remedies under the Installment Payment Agreement, the Guaranty Agreement, and at law and in equity.
